### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

Sub-section (1) of section 3 of the Kerala Farmers’ Debt Relief Commission Act, 2006 (Act 1 of 2007) empowers the State Government to constitute the Kerala Farmers Debt Relief Commission Sub-section (2) of Section 3 specifies the manner in which the Commission has to be constituted and sub-section (3) empowers the State Government to nominate the Chairman and Members of the Commission. Government have decided to constitute the said Commission and nominate the Chairman and Members in accordance with the above provisions.

The notification is intended to achieve the above object.
