### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

In exercise of the powers conferred under Sub-section (1), (2) and (3) of section 3 of the Kerala Farmers' Debt Relief Commission Act, 2006 (Act 1 of 2007) the Government of Kerala have constituted the Kerala Farmers' Debt Relief Commission. The term of office of the members of the Commission nominated vide G.O(P)No.33/2018/RD dated 12<sup>th</sup> June, 2018, and published as SRO No.389/2018 in the Kerala Gazette Extra Ordinary No.1571 dated 12<sup>th</sup> June, 2018, is to expire on 15<sup>th</sup> July, 2021. Hence the Government have decided to nominate new Chairman and members to the said Commission with effect from 16<sup>th</sup> July, 2021.

The notification is intended to achieve the above object.
