Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per clause (vii) of section 2 of the Kerala Farmers' Debt Relief Commission Act, 2006 (1 of 2007), the liabilities due from the farmers on or before the date of commencement of the Act is included as debt. The liabilities incurred after the said date, namely, 18th January, 2007, do not come under the Act. The Kerala Farmers' Debt Relief Commission (Amendment) Ordinance, 2012 (40 of 2012), empowered the Government to bring the debt liabilities upto a specific date in respect of any distress affected area within the purview of the Act by Gazette notification. Now, Government have declared Wayanad District as distress affected area vide G. O. (Ms.) No. 279/2011/AD dated 30th December, 2011 and also decided to bring all agricultural debts up to 31st October, 2011 of the said District, within the purview of the Act, by notification.

This notification is intended to achieve the above object.
